PARISH COUNCIL NEWS

The Parish Council wishes everyone a very Merry Christmas and a Happy New Year! It continues to meet formally every month, usually on the first Monday. The Agenda is displayed a few days in advance on the PC Noticeboard near the Shop and there is always an opportunity for public participation at the start of each meeting. In addition one or more Parish Councillors can normally be consulted informally in the Village Shop on some weekend mornings or in the Trusty Servant most Fridays between 6 and 6.30 pm. The Council is keen to support the views of the Community when appropriate and should always be the first port of call when considering a planning application.

Amongst its wide-ranging activities this year the Council has:

- done what it can to maintain and improve parish footpaths and bridleways, obtaining funding when possible
- part-sponsored the provision of a temporary fence in Church Lane to protect hedge re-growth from grazing
- obtained funding to install some cycle racks adjacent to the Village Green
- continued to press the various responsible authorities to repair and maintain our roads and clear blocked highway drains
- sponsored the development of an improved Village website (more details to follow)

WINTER CAR PARK AND ROAD CLOSURES

The Forestry Commission has advised that, amongst others outside our parish, the car parks at Hazel Hill, Ocknell Pond, Brockishill Green, and Minstead Road will again be closed from 1st November 2013 to 31st March 2014. In addition NFDC has applied for temporary closure of a number of roads in the Village for repairs and surface treatment (Operation Resilience) and the Parish Council will do its best to ensure adequate warning is given once the detailed programme is available

BEAT SURGERIES

As most are aware, there have been a few thefts and attempted thefts in our area recently which may be a symptom of the darker evenings. As well as making sure your main property is secure you are advised to take extra care to lock your outbuildings, sheds and motor vehicles. Advice and information is included in the monthly beat report which can be seen on the PC Noticeboard by the Shop, on the Village website and is attached to the appropriate eNewsletter. Monthly Beat surgeries are held at the Village Shop on the first Wednesday of every month from 9.30 am to 10.30 am. CYCLING IN THE NEW FOREST

The New Forest National Park Authority has recently won funding of £3.57million from the Dept. for Transport to encourage family friendly cycling in the New Forest. This will be match funded by £2.2million from the private sector and local authorities. Their plans include:

- a new cycle hire/information hub by Brockenhurst Station
- · Boris Bikes for the Forest
- pedal buses to local centres and attractions
- new signage to link New Forest cycle routes with those outside
- a grant scheme for improvements to cycle facilities

This scheme is due to be fully up and running by March 2015 so things should start to happen fairly quickly. We strongly suggest that anyone interested should read the additional information and bid documents on the NFNPA website at http://www.newforestnpa.gov.uk/info/20105/sustainability/282/family_cycling_experiences. Meanwhile, as have many other New Forest Councils, Minstead Parish Council has written to all the various authorities involved in staging the recent Wiggle New Forest 100 Sportive event in early October strongly expressing the concerns of the community about the lack of prior information, the number of participants and their failure to follow agreed guidelines. This event has undoubtedly damaged the cause of cycling in the New Forest and it is hoped that any future events will be properly managed to take full account of their impact on other users of the Forest.

NEW HOTLINE CARDS FOR RESPONSIBLE DOG OWNERS

Hotline cards and window stickers designed to encourage responsible dog walking in the New Forest have been unveiled. They have been produced by the New Forest National Park Authority in collaboration with the New Forest Dogs Forum and are designed to help keep the forest clean of dog mess, protect Forest animals and birds, and provide a safe and considerate environment for everyone. COUNCIL TAX CONTRIBUTION

All those of working age, who currently receive local Council Tax Support (formerly Council Tax Benefit), may have to pay a minimum 20 per cent towards their Council Tax bill in future when New Forest District Council makes changes to its support scheme in 2014. Currently, the minimum contribution is 8.5 per cent. Council Tax Benefit was abolished by the government at the end of March 2013 and all local councils have had to replace it with local Council Tax Support. At the same time, government funding to provide this support has been cut by around £1 million in the New Forest meaning the new scheme cannot be as generous. Without making changes to the local support scheme, the loss of funding would result in either reductions of local services or higher Council Tax. Decisions on the way ahead are imminent and all affected will be informed as soon as practical.

ANIMAL TRAFFIC DEATHS

Now the clocks have gone back the NPA and the Verderers are urging drivers to take extra care when driving across the New Forest this winter in a bid to halt the startling rise in pony and cattle road deaths. There have been 48 animal traffic deaths so far this year, up to 30 September, an increase of 20 per cent compared to the same period in 2012. During winter's shorter daylight hours animals will be even more vulnerable. If you witness or are involved in an accident involving a pony, donkey, cow, pig or sheep, call the Police (999 for an emergency or 101 if it's not an emergency). Animal emergency hotline cards also give you the numbers to call if you see sick, injured or distressed animals. DON'T FEED THE PONIES!

Everyone is reminded not to put food out for forest ponies. Food dumped on verges, however well-meaning, encourages the ponies to hang around waiting to be fed and interrupts their normal foraging patterns; it encourages them to take risks with traffic that they might otherwise avoid; and, most importantly, it can KILL them! Ponies do not 'share' food! A bucket full of apples will be eaten by the dominant mare and can easily cause colic and a slow, painful death. If you have excess apples either give them to a neighbour, put them on your compost heap or dispose of them as garden waste.
