#### **New Planning Applications**

17/00385 Bay Tree Cottage. Stable block; driveway; gate; vehicular access (amended plans). Comment No 4 because: (a) Inappropriate over-development of the site and nuisance to neighbours in contravention of NPA's Recreational Horse-keeping Strategy; (b) Close proximity to Grade II listed building. This parish council suggests that the applicant's requirements would be better served by erecting a temporary structure on land she rents for grazing.

**17/00411** Chalford Manor. 2 x single-storey extensions; glazed links; external alterations including solar panels; render. **Comment No 1.** 

17/00469 Fleetwater Farm. Conservatory. Comment No 2 because we agree with Conservation Officer that there is a concern with its design, form and siting – it is not considered to best preserve the character and appearance of the dwelling or the conservation area and is therefore not in-line with Policies DP1, DP6 and CP7 of the New Forest National Park Core Strategy and Development Management Policies (DPD).
