Below are details of the partner agencies who deal with incidents that are often reported via the police. By contacting the agency directly you will enable them to gain better details of the issue and may result in a more effective response.

Barking dogs – Complaints about barking dogs are dealt with by the Environmental Protection Department who can be contacted on 023 8028 5411. More details are on their website http://www.newforest.gov.uk/index.cfm?articleid=1531.

Bonfires – Complaints about nuisance bonfires are dealt with by the Environmental Protection Department who can be contacted on 023 8028 5411. More details are on their website http://www.newforest.gov.uk/index.cfm?articleid=4230.

Lost/found/stray dogs –If you have found a stray dog or have an enquiry regarding a lost or found dog then during office hours please call the Dog Warden Service on 023 8028 5411. If you find a stray dog outside of our normal office hours then please contact the holding kennels on 023 80 510065 as it may be possible for you to take the dog there. **Please note the kennels will not collect the dog from you.**

Motorcycles/vehicles causing a nuisance on private land – If the person has permission from the land owner then complaints about vehicle nuisance on private land are dealt with by the Environmental Protection Department who can be contacted on 023 8028 5411.
