5. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Appletree Court, Beaulieu Road, Lyndhurst, SO43 7PA by 5 pm on Tuesday, 28th April 2015.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, or for employment reasons, where the physical incapacity/reason occurred after 5 pm on Tuesday, 28th April 2015, must reach the Electoral Registration Officer at Appletree Court, Beaulieu Road, Lyndhurst, SO43 7PA by 5 pm on Thursday, 7th May 2015.
