A resident expressed appreciation of efforts of the Parish Council to reduce problems of speeding traffic along Mill Lane. HCC Highways is waiting until after the summer before considering data gathered and any action because this year, 2021, is not expected to be typical. Cllr Taylor has recently outlined in emails the PC position and any representation to the authorities *must* be by residents.

- Beat Report circulated. Residents in Football Green have expressed concerns about antisocial behaviour in car park. They feel that their concerns have not been fully appreciated – Cllr Bennett to speak to PCSO Williams about this.
- Consultative Panel meeting topics discussed included: the likely effect of increased numbers of people visiting the New Forest during the summer; the Fawley site and the new water plant.
- Website security regular change of passwords is now required.
- Quadrant meetings are being planned with next meeting probably in May.
- Village Hall cladding continues apace.

9. Report from Lengthsman

During March he worked on footpaths:

- Footway opposite Court House scraped off mud + leaf mould and cut back whips.
- FP 4 scraped off mud and leaf mould, cut back whips and strimmed grass edge.
- FP 5 strimmed grass, cleared path and cleared pipe at the end of the ditch.

Councillors reported that the hedge opposite Old Court House needs cutting and one section needs relaying. Also that Footpath 5 is flooded where the ditch ends – the pipe under the path from the end of the ditch may be blocked. Cllr Saunders to assess what should be done.

21. Matters raised by Councillors

- More signage is unlikely to solve problems with speeding motorists.
- There have been several incidents recently when cars have missed the turning off A31 on to C17 and have ploughed into the fence instead. With the fence damaged there is increased risk of animals getting on the A31, and on one occasion it was three weeks before the fencing was mended. Cllr Smith to report future damage via Highways website.
- Cable still hanging low on Lyndhurst Road near Minstead Road car park. Openreach is aware.
- Agreed to change date of June meeting from 7th to 14th June.
