Ordinary Meeting of Minstead Parish Council Hybrid Meeting – Danby Room & Virtual Meeting Monday 1 November 2021 at 19.30

1. Apologies for Absence

2. Public Participation Period

4. To confirm the Minutes of the Ordinary Meeting held on 4 October 2021

These had been published and were confirmed and signed.

It was also noted that minutes for Ordinary Meetings July, August and September contained a typo and stated that the minutes approved were of the AGM rather than Ordinary meetings. The meeting agreed to correct and re-sign and publish the minutes of each of those meetings.

Cllr Heron had sent responses to question raised by councillors which were discussed.

• Cllr Taylor to continue to monitor and follow-up on football green roadsides

Cllr Mrs Andrews (NFDC) provided an email update prior to the meeting. Report as follows:

I attended the demolition of the Fawley chimney on 31st October. It was a wet, windy and muddy experience but it was worth getting up at 04.15 to see the spectacle. I wrapped my "boot" in a recycling bag which kept me dry while hopping through running water. When the second explosions went off the pressure of the blast was extraordinary and went right through my chest. A most surprising feeling. Once the dust settled there was an almost reverent hush and I realised, almost emotionally, that the skyline would never look the same again.

It was clever timing coinciding with COP26 and marking the end of the use of carbon fuels at Fawley. Looking to the future, the demolition of the chimney has made way for the planned £1bn Fawley Waterside scheme incorporating 1,500 homes, given approval in July 2020 by NFDC.

The Council appoints four Members to NPA. In making appointments, the Cabinet give careful consideration to selecting the most appropriate representative, taking into account the nature of the appointment and other issues such as local representation and the relevant experience and expertise of the appointee. I was appointed to fill a vacant position with immediate effect. I believe it will be beneficial to have a Cabinet member of NFDC working with the NPA.

8. Reports from Parish Representatives

- PCC Police continue to monitor car parks for unlawful activity
- Consultative Meeting was attended by Cllr Taylor who reported on presentations of planned introduction of bird species to the forest
- Gigabit Cllr Causton has submitted for the scheme and awaits details before next actions.
- Village Hall cladding progress continued, and fund-raising quiz night has been held

9. Report from Lengthsman

For October the Lengthsman had submitted a risk report conducted in the village which was reviewed by the council.
